Who is processing your data?

The 19th EUROPEAN SYMPOSIUM FOR SUICIDE AND SUICIDAL BEHAVIOUR (19th ESSSB conference, the controller) is registered under the Association for Education and Research of Suicide Prevention ("Foreningen for Uddannelse og Forskning i Selvmordsforebyggelse , FUFSS") as a non-profit association in Denmark (CVR: 30147049).

Why are we processing your personal data?

Your personal data are being processed for the purposes of the legitimate interests pursued by the 19th ESSSB conference. The objectives are:

- to promote, organize and to carry out the conference on suicidal behaviour.
- to foster network and cooperation among scholars

What type of information is collected from you?

The personal information we collect includes your name, address, affiliation, e-mail, and phone number (if provided). Information are stored in a password protected and secure section of our website.

How is your information used?

Personal data are used for continuous administrative purposes, such as:

Sending you information and updates regarding the 19th ESSSB conference and events associated with the conference, such as the social program.

Where do we get the data from?

We only store data that was provided by people themselves or otherwise transferred after approval by the individual themselves. We do NOT store data on credit cards, such as number of a credit card that was used for payment of membership fees.

How long do we store your information?

Data are stored until the end of the 19th ESSSB conference. Three months after the end of the conference all personal data will be deleted.

How are your data shared?

Only staff affiliated with the organization of the 19th ESSSB conference will have access to your data. Some data (email addresses and mailing addresses) are shared with the Event organizer, MediCongress Services, with the purpose of communicating with you re. submissions and sending you updates regarding the conference.

Your rights (to control, correct or delete your data)

You have the right to access the data and rectify the data. You can ask us to erase or correct data that is no longer accurate or necessary. In fact, we encourage you to do so.

You can ask us to stop processing the data in certain ways (for example receiving information about certain events). This does not apply in cases where we are processing your data to fulfil our legal obligations. You also have a right to get a copy of your data.

The right to lodge a complaint with a supervisory authority

You have the right to lodge a complaint with a supervisory authority. The 19th ESSSB conference is subject to the Danish Data Protection Agency (“Datatilsynet”), Borgergade 28, 5. sal, 1300 København K., 3319 3200, dt@datatilsynet.dk.
